# I. General Description and Objectives of the Course

This course is meant for sophomore students of the Law division who completed the Intro to Civil Law course; and, for students from other departments who completed the Intro to Law course. The course provides a comprehensive overview of the legal framework guiding the work of business entities in Kyrgyzstan. The course covers such issues as types of forms of business, creation and liquidation of entities, bankruptcy procedures, securities markets, and corporate governance.

### II. LAW DIVISION AND COURSE LEARNING OUTCOMES

# III. Course Readings

An English version of the Civil Code will be available on the e-course, however, the Latest Russian edition of the Civil Code remains the main point of reference for this course.

The Code as well as other normative legal acts can be accessed by students via either Toktom or Paragraph databases, both are available on campus. If students face difficulties using these databases, they are recommended to turn to the instructor or to the Library staff.

# IV. Teaching Methods

The class will meet twice a week. This course does not use traditional method of lecture and seminar division. There is going to be hybrid of lecture/seminar every class or it can be called as interactive lecture method. This method implies students to read new materials beforehand and be ready to discuss the given materials in class. Such method helps and equips the student a self-learning skill, which he/she will need in their further studies.

The main teaching methods used include the Socratic Method, which is widely used in law schools and is a way of engaging large groups of students into discussion of course topics through asking them questions and guiding them right to the core issues. This method equip students with analytical and critical thinking since the student is not given the answer to question but the student should find an answer himself by answering instructor's question.

#### Topics to be covered:

Inheritance: the grounds of occurrence, change and termination. Subjects of hereditary legal relations. Opening of the inheritance. Call to inheritance. Testamentary waiver and testament. Testament: the concept, form, types, rules of commission. Notarized testament. The will, equivalent to a notarized. Closed testament. The will made in extraordinary circumstances. Execution of wills/testament. Change and cancellation, invalidity of wills.

### Week 2 / 21.01 & 23.01 Succession Law

#### Topics to be covered:

Inheritance by law. Queues of heirs by law and their composition. Inheritance of disabled dependents. Inheritance of adopted and adoptive parents. Terms of accepting inheritance. Procedure for accepting inheritance. Refusal of inheritance: concept, rules of commission and consequences. Taking measures to protect inherited property. Management of hereditary property. The division of inheritance between the heirs. Responsibility of heirs for the debts of the testator. The procedure for registration of rights to inheritance. The procedure, conditions, term for issuing a certificate of inheritance. Expenses of heirs for the acquisition of hereditary property.

#### **Succession Law**

#### Topics to be covered:

Inheritance of rights associated with participation in economic partnerships and companies, production and consumer cooperatives. Inheritance of an enterprise and property of a member of a peasant (farm) economy. Inheritance of things with limited turnover. Inheritance of land. Inheritance of unpaid amounts provided to a citizen as livelihood and property provided to the testator by the state or the municipality on preferential terms. Inheritance of state awards, honorary and memorable signs. Judicial protection of the right of inheritance. Inheritance of intellectual property.
