### General Course Description

The aim of the course *Natural Resources Law* is to review legal aspects of natural resources ownership and use in the Kyrgyz Republic. The course will cover regulation of the following natural resources: subsoil, land, forest, water, flora and fauna. The course addresses such issues as title to different natural resources, principles of use of resources, state regulators in natural resources sector, framework laws concerning different natural resources. Taking into account the social and economic importance for the Kyrgyz Republic of land, mining and environmental protection issues, special attention will be given to the practical aspects of regulation of land, mining industries and environmental protection legislation of the Kyrgyz Republic. The course is divided into 4 sections each addressing specific natural resource.

Students are expected to read class materials (mainly legal acts, court decisions) before the class and participate in class discussions. There will be individual and/or group assignments/presentations. Guest speakers and site trips will be organized when possible. Reading materials will consist of legal acts of the Kyrgyz Republic, court decisions available at the legal database “Toktom”, expert articles (provided by the course instructor). Additional section specific materials will be announced and/or provided by the course instructor at the beginning of each section of the course.

The course is taught in English language, section tests, final exam, individual and group presentations shall be prepared and presented in English language.

### Grading

Students may earn up to 100 points and will be graded as follows:

Final grade of the student will compose of the following:

1. 20 points - class participation (attendance, active and constructive participation during the class discussions, individual and group presentations)
2. 40 points - 4 section-based tests (10 points per each section test)
3. 40 points - final exam

Failure to take final exam and/or 2 or more section based tests will lead to grade “F”. Failure to attend the class 3 or more times will lead to automatic deduction of 10 points. Up to 5 point extra-credit can be earned for individual presentations and/or written paper.

Plagiarism, cheating in any form, unauthorized group work and attempt of such during the section and final tests, in written papers will lead to automatic grade *F* for the course.

### Use of electronic devices

Use of electronic devices including but not limited to use of mobile phones, notebooks, netbooks, tablets, book readers and similar shall be turned off or put on mute mode in order not to interfere with the class discussion. Use of any electronic device, including phones and notebooks/netbooks during the section tests, final test is strictly prohibited and will automatically lead to grade *F* for the course.
